Mayor's mid biannual budget presentation is Sept. 30<sup>th</sup>. EDC is Researching paid parking and b&o tax, EDC meeting is open to the public on September 24th 6pm Frances Anderson hybrid. Parking slowly incrementally, b&o tax is more challenging re determining revenue, wants to meet with businesses to see if businesses have strong feelings about other options. October meeting with businesses to get their opinions.
